“KIXA Power Trip Concert Official Rules”

(effective Monday, May 1st, 2023 12am)

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.

- 1. CONTEST PERIOD:** Contest begins at 12AM on Monday May 1, 2023 and ends on Saturday, June 10th, 2023. (“Contest Period”), excluding weekends during the Contest Period Monday May 1, 2023 and ends on Saturday June 10th, 2023
- 2. HOW TO ENTER:** During the Contest Period, listen weekdays to 1065 THE FOX (KIXA FM) between the hours of 6 AM and 6 PM PST. During the designated time each weekday, “Station” will play a “cue to call/sounder” that will solicit listeners to call for a chance to qualify to win a pair of Power Trip tickets. Limit 4 (4) qualifiers per day. A “day” is defined as a twenty-four (24) hour time period beginning at 12:00:01 a.m. (midnight) PST and ending at 11:59:59 p.m. PST. The time clock of the Contest Administrator is the official clock for this Contest. Stations will play the cue to call 4 times per day between 6 am and 6 pm.
- 3. ELIGIBILITY:** The Contest is open only to individuals who are legal residents of the United States residing in California in the Stations DMA who are 18 years of age or older at the time of entry. Employees, contractors, directors, and officers of El Dorado Broadcasters LLC or EDB VV License LLC or associated companies, Company (“Sponsor”), and the immediate family members (spouse, parent, child, sibling, grandparent, and/or “step” of each) and those living in the same households as such employees are ineligible.
- 4. PRIZE DETAILS:** Each qualifier will be entered for a chance to win a pair of tickets to Power Trip, Oct. 6-8, 2023 at the Empire Polo Field, Indio, Ca. Station will qualify no less than 106 qualifiers and no more than 108. Each qualifier is required to attend the final contest on June 10th, 2023 from 4-8pm PST at Café 247, Lucerne Valley, Ca. Anyone that has not prequalified may enter on June 10th, 2023 at the final event for one last chance to qualify. Station will conduct a Reverse Drawing eliminating qualifiers every half hour from 4:30-7:30pm PST until we get to the final three (3) contestants. Two (2) names will then be drawn and each of those qualifiers will get a pair of 3 day General Admission passes to Power Trip worth \$1198.00. Winners will receive their tickets no later than October 5, 2023 and after completing and executing a W-9 Form. All taxes associated with the prize is the responsibility of the winner, as further described in section 7. Tickets will be digitally transferred to winner via Goldenvoice
- 5. WINNER NOTIFICATION:** Potential winner will be notified in person at the event on June 10, 2023
Stations/sponsor is not responsible for suspended or discontinued wireless service which may result in a potential qualifier not receiving initial prize notification. Once potential winner notification is confirmed to Stations/sponsor, the potential prize winner may be sent an Affidavit of Eligibility and Liability/Publicity Release (where permitted by law) to be signed and returned within the number of days indicated on the Affidavit. In the event (i) the attempted notification is returned as undeliverable without a forwarding address; (ii) a telephone or text message notification is not confirmed to Stations/sponsor within twenty- four (24) hours; (iii) any required documents are not returned within thirty (30) days; or (iv) if winner is unable to accept the prize as stated, prize will be forfeited and may be awarded to an alternate winner.
- 6. In such event, Sponsor shall immediately suspend all drawings and prize awards, and Stations/sponsor reserves the right to award any remaining prizes (up to the total set forth in these Official Rules) in a manner deemed fair and equitable by Sponsor, such as by way of example and not by way of limitation, in a random drawing from among all eligible, non-suspect entries received up to the time of the impairment, and Sponsor shall not have any further liability to any participant in connection with the Contest. Sponsor may modify and amend these Official Rules as they may appear online from time to time during the Promotion for clarification purposes without materially affecting the terms and conditions of the Contest. **NOTE: Online listening via station apps, website, tunein or other streaming platforms have up to a 5 minute delay from the stations terrestrial, on air station signal. El Dorado Broadcasters LLC, EDB VV License LLC, All Related Stations, Companies and Sponsors assumes no liability for a digital latency or buffering signal.**

7. WINNER RELEASES: By participating in the Contest, entrants release The Radio Stations and Sponsors from and against any and all liability, claims or actions of any kind whatsoever for injuries, damages, or losses to persons or property which may be sustained in connection with submitting a play or otherwise participating in any aspect of the Contest, the receipt, ownership or use of any prize awarded, or while preparing for any prize-related activity or any typographical or other error in these Official Rules or the announcement or offering of any prize. The winner shall bear all risk of loss or damage to their prize after it has been delivered. Sponsor and Promotion Parties make no representations or warranties of any kind concerning the appearance, safety or performance of any prize; except for any express manufacturer's warranty as may be included with the prize. Except where prohibited by law, winner grants to Sponsor the right to print, publish, broadcast and use worldwide in any media now known or hereinafter known, the winner's name, address, voice, statement, picture or other likeness, without additional compensation, for public relations, advertising and promotional purposes as may be determined by The Radio Station and Sponsor.

No substitution of prize is offered, no transfer of prize to a third party is permitted, and non-cash prizes may not be redeemed for cash value except at Stations/sponsor's sole discretion. All other expenses on the receipt and use of the prize not specifically mentioned herein are solely the responsibility of the winner. Any difference between the stated value of any prize and the actual retail value will not be awarded. Any portion of a prize not accepted by winner will be forfeited. Upon forfeiture for any reason as stated in these Official Rules, no compensation will be given. All federal, state and local laws & regulations apply.
