- 1. CONTEST PERIOD:** Contest begins at 6AM on Monday August 11th, 2025 and ends on Monday, September 1st, 2025 at 11:59PM . ("Contest Period")
- 2. HOW TO ENTER:** During the Contest Period, go to the station website www.thefox1065.com and enter to win a pair of tickets to see Billy Idol September 12th at Acrisure Arena in Palm Desert. Tickets will include a meet n greet with Billy Idol. Listeners may enter once per week and must complete the entire entry form for a chance to win. Entries will be accepted until 11:59:59pm on September 1st, 2025
